The General Fund is the general operating fund of the Charter School. It is used to account for all financial resources except those required to be accounted for in another fund. The General Fund reported a positive fund balance of \$3,072,756 for the reporting period on the modified accrual basis. Approximately 91% of general fund revenues come from district payments for per pupil enrollment. Instructional and Support Services expenditures account for 98% of general fund expenditures.

The Food Service Fund is used to account for all financial transactions related to the food service operation of the Charter School. For the reporting period the Food Service Fund had a change in net position of (\$33,096). The Food Service Fund is financially supported by transfers from the General Fund when needed. Food Service is considered an essential service for student well-being and enrollment by the Tidioute Community Charter School.
